His concentration will be to lead the workshop with a focus on a practical framework for developing robust case theory, building persuasive arguments, and presenting evidence in a way that assists a judge to make good decisions.

The preparatory sunset session prior to Day 1 will ensure timely preparation to turn improved case theory into practice.

Craig will highlight the Case Brief, purpose-built for the workshop. This proven lecture will assist you in developing advocacy confidence over the following two days.

### SMALL GROUP MENTORING (ALL DAY)

Working with your Brief, prepare your Opening and Evidence in Chief component presentations. Opportunity for individual presentations will be provided to every participant in your Small Group. You will be mentored by a specialist guest Barrister, building confidence with their guidance and encouragement. Accelerated learning does not have to be uncomfortable: so every staff member will receive feedback on their opening or closing addresses using film footage.
